Norfolk Safeguarding Adults Review June 2021: 3 adults with Learning Disabilities

Norfolk Safeguarding Adults Board (NSAB) publishes an important Safeguarding Adults Review (SAR) into the deaths of three young adults: Joanna, “Jon” and Ben (all in their 30s). They had learning disabilities and had been patients at Cawston Park Hospital. They died within a 27-month period (April 2018 to July 2020).

Joanna, Jon and Ben were admitted to the hospital under sections of the Mental Health Act (1983). Joanna and Jon originated from London boroughs. Ben was from Norfolk. Their behaviour was known to challenge services and sometimes their families. Joanna and Jon had experienced several out-of-family-home placements. Ben had lived with his mother for most of his life. Their placement at the hospital resulted from personal and family crises.

The review makes 13 recommendations for critical system / strategic change. In addition, it contains the following key learning for practitioners:

- the critical role for professional curiosity and challenge
- the trauma of transition
- meaningful support for individuals with behaviours that challenge others
- critical responsibility for staff to advocate reporting and openness
- where the victim of abuse doesn't want to 'complain'
- the importance of meaningful occupations
- making sure attention is given to physical health needs
- mental capacity

Modern Slavery Rapid Read

Modern slavery is a hidden crime, and its victims may be especially isolated during the coronavirus outbreak. It is not the health professional's job to decide if someone is a victim, but if you do have concerns, raise them with your safeguarding lead or contact one of the organisations listed within the attached rapid read document.

Unaccompanied Asylum-Seeking Children (UASC)

In October 2021 there has been an increase in the numbers of unaccompanied asylum-seeking children being placed in Surrey. As unaccompanied asylum-seeking children under the age of 18 these young people become looked after by the local authority under Section 20 of the Childrens Act 1989. UASC have the same rights as other looked after children. They are entitled to statutory health assessments, registration with a GP, dental care, optician appointments and universal services. A health assessment will take place when an UASC comes into care. Recommendations from this assessment will be shared with the GP and may ask them to support young, people, carers and social workers by arranging the following services through GP practices.

- Catch up immunisations
- Referral to local TB screening services
- Blood tests for

HIV, Hep B, Hep C and syphilis

FBC for anaemia and eosinophilia for helminth infection

Nutritional deficiency Vitamin D, ferritin, LFTs.

Foster carer, special guardianship, and independent visitor medicals.

Foster carers offer children a safe and caring family when their biological parents cannot take care of them.

Special Guardianship is a formal court order which places a child or young person with someone permanently and gives this person parental responsibility for the child. This could be a grandparent, close relative, or a family friend.

Local Authorities may have a statutory duty to offer all children who are looked after an **Independent Visitors**. The visitor is a volunteer who provides a good, stable, adult role model for a young person who would like to have an adult in life and may have little contact with their own family. In Surrey independent visitors can be provided for looked after children up to the age of 18 and the relationship can continue when young people leave care.

As part of the recruitment and re-approval process for these roles, medicals or medical reference requests are required to ensure carers, family members and volunteers are healthy and can meet the needs of the child or young person. For foster carers and special guardians these are statutory medicals not private medicals. They are not part of a commissioned service and GPs are asked to complete these by social care, a fee is provided. Although it is not a statutory requirement for Independent Visitors to have a medical reference request, it is part of Surrey County Council's Independent Visitor Service's recruitment procedures to ensure volunteers working with looked after children can undertake the role with some of the county's most vulnerable children, and volunteer consent is obtained for this.

These medicals are part of our wider safeguarding work as the definition of safeguarding is to ensure the best possible outcomes for the child to reach their full potential as well as the initial child protection function. A delay in these medicals and medical reference requests can result in children moving placement, not being placed with their own family or unable to obtain support from a volunteer. This can have a negative impact on the child and their whole family.

We are aware of the current pressures and workload in general practice at this time and appreciate how difficult it is to find the time medicals. However, we would ask you to consider prioritising completion of foster carer and special guardianship medicals, and independent visitor medical reference requests.

General Practice Guidance and research into Menopause and Domestic Abuse from Against Violence and Abuse (AVA) in Partnership with IRISi

This briefing explores the experiences of women who have been through domestic abuse and menopause, bringing together key findings from focus groups held in May 2021 as part of AVA's Stuck in the Middle with You project. This work was supported by two peer researchers with their own lived experience of domestic abuse and/or menopause. The focus groups explored women's experiences of menopause and domestic abuse, women's experiences seeking support from General Practitioners, and the types of support women would like to see made available. These early findings have informed AVA's guidance for General Practitioners on domestic abuse and menopause, as well as AVA's priorities for future research, and campaigns to improve the response to domestic abuse and menopause.
